

18 This Court has considered the *Application of the Official Committee of Unsecured Creditors*
19 *of PrediWare Corporation for Order Approving Employment of Pachulski Stang Ziehl Young Jones*
20 *& Weintraub LLP as Committee Counsel* (the "Application"), and the declaration of John D. Fiero in
21 support thereof ("Declaration"). It appears that Pachulski Stang Ziehl Young Jones & Weintraub
22 LLP ("PSZYJ&W") does not hold, or represent any other entity having, an adverse interest in
23 connection with this case, that its employment is in the best interests of the estate, and that
24 PSZYJ&W is a disinterested person under applicable sections of the Bankruptcy Code. It further
25 appears that due and sufficient notice of the Application has been given under the circumstances and
26 that no hearing on the Application is required. Based on the record before the Court, and after due
27 deliberation and sufficient cause shown, it is hereby

28 **ORDERED** that, pursuant to sections 1103(a) and 328(a) of the Bankruptcy Code, the
Official Committee of Unsecured Creditors, appointed on May 3 and 5, 2006, in the above-captioned

1 bankruptcy case, is authorized to employ PSZYJ&W as its counsel herein on the terms and
2 conditions set forth more fully in the Application and the Declaration, effective as of May 8, 2006.

3 **ORDERED** that no compensation will be paid by the Debtor or any other person or entity
4 for services rendered by PSZYJ&W for the Committee in this case except upon application and
5 approval by the Court.
