15 **CONTINUING OBJECTION TO MOTION UNDER 11 U.S.C. §§ 105(a) and**
331 ESTABLISHING PROCEDURES FOR INTERIM COMPENSATION
16 **AND REIMBURSEMENT OF EXPENSES OF PROFESSIONALS**

17 Sara L. Kistler, Acting United States Trustee (UST) objects to the Motion
18 under 11 U.S.C. § 105(a) and 331 establishing procedures for interim
19 compensation and reimbursement of expenses of professionals in this case under
20 chapter 11 of the Bankruptcy Code. 11 U.S.C. §§ 1101 et seq. The UST is
21 responsible for, *inter alia*, supervising "the administration of cases . . . under
22 chapter . . . 11" of the Code. 28 U.S.C. § 586(a)(3). The United States Trustee
23 renews the following objections:

24 1. The UST requests that the Monthly Application's time records comply
25 with this Court's Guidelines for Compensation and Expense Reimbursement of
26 Professionals and Trustees ("Guideline") ¶ 11.

27 2. The UST further requests that the Monthly Application also provide a
28 brief description of the results obtained for each project. *See* Guideline ¶ 3.

1 3. The UST requests that the 10-day period for objection be extended to
2 fifteen days.

3 WHEREFORE, for the foregoing reasons, the UST respectfully requests
4 that this Court not approve the motion as submitted and for such other relief as the
5 Court deems appropriate.
